This letter is to inform you, that due to the Agency's change in Project Manager extensions for our submittal of certain review comments may be necessary. The following is a list of the document reviews that <u>may</u> be affected and EPA's current schedule for providing the appropriate comments:

1. <u>DOCUMENT:</u> The Draft RI/FS/PRAP for the Shallow Aquifer at the Hadnot Point Industrial Area Operable Unit.

<u>SCHEDULE:</u> EPA intends to have comments to the Navy no later than January 30, 1992 (hopefully, much earlier).

2. <u>DOCUMENT:</u> Draft Final Remedial Investigation Report for Hadnot Point Industrial Area Operable Unit (Shallow Soils and Castle Hayne Aquifer).

<u>SCHEDULE</u>: EPA will need time to conduct a complete review this document, therefore we propose the "Finalization of Primary Documents" be extended to 60 (as opposed to 30) days in this particular instance. This will prevent a "dispute resolution" proceeding while all the parties come to agreement as to the completeness of these documents.

3. DOCUMENT: Draft RI/FS Project Plans for Sites 6, 48, and 69.




