Dear Mr. Butler:

We request you attend the subject meeting to be held at MCB Camp Lejeune, Building 1, Room 126 at 9:00 a.m. The primary topics of discussion will be:

- The Draft Final RI/FS and Proposed Plan for the Interim Remedial Action for the Shallow Aquifer at the Hadnot Industrial Area (HPIA),
- The schedule of activities for reaching a ROD for the Interim Remedial Action for the HPIA Shallow Aquifer, and
- The Draft Final Project Plans for RI/FS work at Sites 6, 9, 48, and 69.

Other significant issues regarding ongoing environmental restoration activities at MCB Camp Lejeune will also be discussed.

We also request that you bring the technically cognizant personnel from the Water Quality and Groundwater Sections of the NCDEHNR Division of Environmental Management to this meeting, as these personnel had substantial comments on the Draft versions of the FS for the Interim Remedial Action for the HPIA Shallow Aquifer. Their comments specifically concern use of the HPIA Sewage Treatment Plant to treat the TCE contaminated groundwater. In response to their comments, we will submit a supplementary document to the Draft Final FS, subtitled "Draft HPIA Sewage Treatment Plant Evaluation". As we are maintaining an accelerated schedule for completing the ROD for the HPIA Interim Remedial Action, the attendance of these personnel at the subject meeting is vital and would provide for better discussion and expeditious agreements on any necessary changes.
