Dear Mr. Meyer:

Enclosed please find two copies of the updated Federal Facilities Agreement for Marine Corps Base, Camp Lejeune dated September 27, 1989.

As discussed during a telephone conversation on September 27, 1989 between Ms. Beverly Spagg of the U.S. Environmental Protection Agency (EPA), Region IV and Ms. Sheila Ashton of this Command, the enclosed draft Agreement represents the EPA's final position and the end of their obligation to participate further in discussions between the State of North Carolina and the Marine Corps on the three outstanding issues identified below. A copy of the enclosed draft Agreement and a "clean" copy of the same draft Agreement (removing the proposed deletions and the underscores that identify the additions) were provided to EPA for their headquarter's review. Please note that the "clean" copy was left blank in the three locations where we have yet to resolve the language to be included in the final Agreement.

We believe that the three outstanding issues that remain to be resolved between the State of North Carolina and the Marine Corps are:

- a. The identification of the State's Party to the Agreement;
- b. The State's proposed revisions to the Force Majeure Section; and
- c. The State's proposed Reimbursement of State Expenses language.

We have indicated in the Agreement our preferred language with regard to item a. above. If this language is unacceptable to you please provide your preferred language with the reasons for your position so we can elevate this issue to our headquarters for resolution.

As discussed during a telephone conversation between Ms. Lee Crosby of your staff and Ms. Sheila Ashton of our Command, items b. and c. will be forwarded to our headquarters for review and approval.
