The Environmental Protection Agency (EPA) has received the Navy's letter of July 16, 1991, proposing a minor amendment change to the Site Management Plan regarding moving the annual SMP submittal date from June 1 to November 15. On July 17, 1991, in a telephone conversation with Mr. Andrew Kissell, EPA clarified its position regarding the change of the yearly update of the Site Management Plan (SMP). EPA's position on this issue, as stated to Mr. Kissell, is that the first "Draft" SMP should be submitted at an early point in the Navy's budgeting process to enable EPA to work with the Navy to request and obtain additional funding for ongoing as well as new work to be performed for that fiscal year at MCB Camp Lejeune. The June 1 date will provide opportunity for EPA to participate in the Navy budgeting process and at this time requests the existing yearly update remain as per the Federal Facilities Agreement.
