Dear Mr. Watters:

This letter requests an extension of the schedule set in the 1995 Site Management Plan for submission of documents related to the RI/FS at MCB Camp Lejeune Operable Unit Number 7 (Sites 1, 28, and 30)in accordance with the Federal Facilities Agreement (FFA) of December 1989. As discussed at our Partnering Meeting of November 8-9, 1994, the requested extension applies to the submittal of the Draft, Draft Final, and Final RI, FS, Proposed Remedial Action Plan (PRAP), and Record of Decision (ROD). The current and proposed submission dates are provided in attachment (a).

The schedule extension is being requested to allow for the collection of a second round of groundwater samples for the purpose of providing additional groundwater data to support the human health risk assessment and the selection of remedial alternatives. These samples will be taken using the low-flow purging technique that has been recently used with success at other Camp Lejeune sites.

At the request of Ms. Gena Townsend, EPA Region IV, at the November Partnering Meeting, this schedule modification will allow the incorporation of the round two sampling results into the Draft RI report. This should help avoid confusion that may have resulted from a Draft RI being published without the round two results and a Draft FS published later which incorporated these results.

The proposed submission dates are based on the fact that the round two validated data will not be available until December 14, 1994, three weeks after the planned submittal date of the Draft RI report. Additional time following the receipt of the validated data is necessary to include the results in the report. Submission of subsequent version of the RI and other documents

(FS, PRAP, and ROD) will be impacted also. However, note that the proposed schedule concludes with the submission of the Final ROD only four weeks later than the original schedule. This is possible because preparation of intermediate documents will be expedited.
