North Carolina Superfund Comments Camp Lejeune MCB Operable Unit 10 Final Basis of Design for Soils Remediation

- 1. Page 3 and Drawing C-1
 The top of the page indicates that the highway through Site 35
 will be four lane. It was noted by NC-DOT during the 9/29/94
 design meeting that the highway design was changed from four
 to six lanes. The change from 4 to 6 lanes should also be
 indicated on Drawing C-1
- The soil sampling frequency noted in Item 1 on Page 5 is not consistent with Section 9.4 of the Groundwater Section Guidelines for the Investigation and Remediation of Soils and Groundwater. These guidelines state that a composite sample should be taken and analyzed for every 200 cubic yards of stockpiled soil. Each composite sample should be obtained from a mixture of six randomly chosen primary samples of approximately equal size. Since this guidance document is being used to establish site cleanup levels (i.e. the Site Sensitivity Evaluation) it is appropriate to use this sampling methodology. Consult Section 9.4 of the guidance document for a complete description of the soil sampling requirements.
- One of the contaminated soils areas designated in the OU 10 Interim Record of Decision is a former UST location near building G-480. This location is not included in the Basis of Design. It is our understanding that the contaminated soil at this location was removed as part of a UST action and the area was subsequently paved over. As a result, it may not be necessary to conduct further soils removals at this area.

The documentation associated with the original soils removal at G-480 is said to be inconclusive, therefore, additional data is needed to determine what, if any remedial actions are needed. It is acceptable to the State to postpone remediation plans for this small area until confirmatory samples necessary to establish the status of the G-480 UST area soils have been obtained and analyzed. A Final ROD still needs to be developed for OU 10 and this area can be a part of that decision if necessary.

It is important in the interim to clearly indicate the status of the G-480 UST area and the actions to be taken in this Basis of Design document.
