1. Cover sheet - Title should read "DRAFT INTERIM RECORD OF DECISION . . . "

2. Page iv, para 3 - This sentence refers to the Record of Decision (ROD) which should be Interim ROD.

3. Page 1, para 2 - Remove the reference to Onslow County in the first sentence.

4. Page 7, para 4 - Building numbers in this paragraph are incorrectly identified as TC74, TC73, and TC70. The correct numbers are TC474, TC473, and TC470.

5. Page 13, last para; page 15, para 4; and page 17, para 2 - Access to the Brinson Creek side of the highway has yet to be determined.

6. Page 19, para 4 - The second sentence: "Conversely, RAA3 (In Situ Air Sparging And Off-Gas Carbon Adsorption)" should read: "Conversely, RAA4 (In Situ Air Sparging . . ."

7. Page 22, first sentence - Should read Interim ROD instead of just ROD.

8. Page 27, para 2 - The third sentence indicates that there is no community interests or concerns to environmental sites. However, numerous community representatives attended the most recent public meeting held in this area addressing the soil remediation alternative selected for implementation at the ABC Cleaners site.

9. Table 3 (Continued) - The category of Evaluation Criteria, Requirements for Agency Coordination for RAA3, RAA4, and RAA5, indicates the requirement to obtain "special permit to perform construction in wetlands", as well as "air and water discharge." Under the Comprehensive Environmental Response, Compensation, and Liability Act, permits are not required but the intent of the permit must be met.
