# Comments concerning the Draft Proposed Remedial Action Plan for Operable Unit No. 4

#### General comments:

- 1. According to this report, the Information Repository and Administrative Record file are maintained at "Building 67, Room 237." The room number should be corrected throughout the document to "Room 238."
- 2. The phone number for the Onslow County Library is (910) 455-7350.

### Specific comments:

- 1. Page 2-2, first paragraph: The following statement "Grease was reportedly disposed of in trenches, then backfilled" is supported by neither the Initial Assessment Study (IAS) nor the Site Summary Report (SSR). While both the IAS and SSR delineate the disposal of grease, no references to backfilling exist.
- 2. Page 2-4, section 2.3.2, fourth bullet: This bullet should also be included as part of section 2.3.1.
- 3. Page 5-6, section 5.2.1: A statement concerning the previous fencing of Site 74 should be included.
- 4. Page 8-3: The name "Mr. Thomas Morris" should be changed to "Mr. Neal Paul."

# Comments concerning the Draft Record of Decision for Operable Unit No. 4

#### General comment:

The fact that IR Site 74 has already been fenced as part of Camp Lejeune's institutional controls should be mentioned in this report.

#### Specific comments:

- 1. Page 2-1, third paragraph: The following statement "Grease was reportedly disposed of in trenches, and then the trenches were backfilled" is supported by neither the Initial Assessment Study (IAS) nor the Site Summary Report (SSR). While both the IAS and SSR delineate the disposal of grease, no references to backfilling exist.
- 2. Page 2-2, first bullet: The term "dichlorofluoromethane" should be replaced with "dichlorodifluoromethane."
- 3. Page 4-1, first paragraph: The term "soil former disposal area material" is ambiguous. Replace this phrase with "soil, and disposal material."
- 4. Page 5-2, third bullet: This bullet should also be included as an element of section 5.1.
- 5. Page 7-1, paragraph 1: Delete "The former remedial alternatives developed for Site 74 are quite similar to the alternatives presented for Site 41."
