Comment Letter by Mr. Patrick Watters dated March 5, 1995

Responses to Specific Comments

- 1. Section 1, Table 1-2. The North Carolina Groundwater Standards for fluorene (280 μ g/L), naphthalene (21 μ g/L) and phenanthrene (210 μ g/L) will be included in the table.
- 2. Section 2.2.3, page 2-6. The section states (on page 2-5) that 34 subsurface soil samples were collected during the Phase II investigation. It also states that 27 of the 34 samples were collected from locations sampled during the Phase I ENSYS field screening investigation. The eighth sentence of the section states that the remaining seven subsurface soil samples were collected from soil borings that were converted into groundwater monitoring wells. All 34 subsurface soil samples were submitted to the laboratory for analysis.
- 3. Section 4.4.2, page 4-8 through 4-12. The Feasibility Study (FS) will discuss an enlarged area of concern in relation to/with the remedial technologies alternatives. It will also discuss the potential for migration of contaminants from the treatment area, and how this affects the evaluation and final selection of a remedial technology(ies).
