Comment Letter by Gena Townsend dated October 30, 1996

- 1. The frequency of the monitoring sampling (semiannually), as stated in the final ROD will be specified in this work plan. If during the course of the monitoring program this frequency is changed a revision to the plan will need to be made to document the modification. This revision will not be made without agreement from state or federal regulators.
- 2. Two reports will be prepared each year; one following each semiannual sampling event. Included in these reports will be figures indicating sampling locations, analytical findings, comparisons to state and federal criteria, time trend graphs, and recommendations. The recommendations will include but will not be limited to the addition or deletion of the number of wells being sampled, action needed to adequately maintain the condition of the wells, and the addition or deletion of analytical parameters from the monitoring program. Also included will be a general evaluation of the overall condition of the groundwater and surface water based on initial RI conditions. This evaluation may result in additional recommendations such as a change in frequency of monitoring, to discontinue monitoring, or to consider implementation of other remedial alternatives at the site.

The term "given acceptance" refers to the fact that no recommendations for changes in the LTM work plan will be implemented without concurrence from state and federal regulators.

The most recent version of the USEPA Region 4, <u>Environmental Investigations Standard Operating</u> <u>Procedures and Quality Assurance Manual</u>, May 1996 will be referenced.
