Baker Environmental, Inc. (Baker) is pleased to submit five sets (including two bound and three unbound) of the Final Interim Remedial Action Design Package for the implementation of an In-Situ Air Sparging Groundwater Treatment System at Operable Unit (OU) No. 10 (Site 35) Camp Geiger Area Fuel Farm. This package includes design plans, performance-based specifications, and a Final Basis of Design Report which contains a construction cost estimate. According to the project schedule this deliverable was to be submitted on May 19, 1997. It was not submitted on that date due to late reviewer comments. Others receiving this design package include Messers. In each case Baker received verbal concurrence for our responses.
