Enclosure (1) is an updated map of monitoring wells in Right-of-Way of the US 17 Jacksonville Bypass on Marine Corps Base, Camp Lejeune property (from existing US 17 to Wilson Bay). This is an amended map from the one dated March 8, 1998. Also provided is updated well information in table format as enclosure (2), Existing Wells Within/Adjacent to US Highway 17 Bypass, Sites 35, 36, and 89. These changes are a result of the meeting and walk-through between Mr. Michael Smith, a representative of our environmental contractor Baker Environmental, Inc., and Mr. Jackson Provost, Resident Engineer, North Carolina Department of Transportation (NCDOT), Jacksonville Office, on April 3, 1998 concerning the identification of monitoring wells located within the US Highway 17 Bypass Right-of-Way (ROW) and easements.

Enclosure (1) is a map that highlights the location of Site 36 polychlorinated biphenyl (PCB)-contaminated soil, monitoring wells that need to be surveyed in by the NCDOT, and wells deleted/added from the March 8, 1998 map. Similarly, enclosure (2) reflects changes to the March 8, 1998 table. This new table lists those wells that were added for abandonment and eliminates those that were not found during the walk-through or no longer need abandonment.
