Dear Dr. Arnold:

The Underground Storage Tank Closure Report received by the UST Section, Wilmington Regional Office on January 14, 2009 has been reviewed. The risk posed by the discharge or release at the subject site is reclassified by the Department as low, as stipulated under Title 15A NCAC 2L .0406. The land use at the site is classified as residential. Title 15A NCAC 2L .0407(a) requires Camp Lejeune to notify the Department of any changes that might affect the risk or land use classifications that have been assigned.

Title 15A NCAC 2L .0407(d) requires Camp Lejeune to comply with soil assessment and cleanup requirements of Title 15A NCAC 2L .0408.

As soil assessment is not complete, a Soil Assessment Report (SAR) prepared in accordance with these requirements and the most recent version of the *UST Section Guidelines for Assessment and Corrective Action* must be received by this office within 90 days of the date of this notice. The SAR must document the horizontal and vertical extent of soil contamination; and, if soil contamination is present at concentrations exceeding the applicable cleanup levels, the SAR must contain a plan and schedule for soil remediation. If the SAR proposes to cleanup soil to or leave in-place soil at concentration levels which exceed the lower of the soil-to-groundwater or residential Maximum Soil Contaminant Concentrations (MSCCs) established in Title 15A NCAC 2L .0411, you must give public notice in accordance with Title 15A NCAC 2L .0409(a) concurrent with the submittal of the SAR. When soil contamination has been remediated, a Soil Cleanup Report with Site Closure Request (SCSC), which demonstrates that soil contamination does not exceed the residential MSCCs, must be received by this office by the date specified in the schedule contained in the SAR.


Failure to comply with the State's rules in the manner and time specified, may result in the assessment of civil penalties and /or the use of other enforcement mechanisms.

Effective October 1, 2004, the Department requires that all work following the submittal of the Limited Site Assessment Report (Title 15A NCAC 2L .0405) be preapproved if State Trust Fund reimbursement is anticipated. To comply with this requirement, a completed Preapproval/Claim Authorization Form, encompassing the required remedial activities, must be received in this office within 14 days of the date of this letter. Upon completion of the preapproved activities, you should submit your claim promptly. Reimbursement funds are budgeted based on completed preapprovals, but lengthy delays in reimbursement can occur if claims are not submitted immediately following work completion.

Because a release or discharge has been confirmed, a Licensed Geologist or a Professional Engineer, certified by the State of North Carolina, is required to prepare and certify all reports submitted to the Department in accordance with Title 15A NCAC 2L .0103(e) and 2L .0111(b).
