Dear Mr. Reed:

This document contains details associated with soil removal actions at buildings PP-3326, PP-3330, PP-3332, PP-3350 and M-230. These sites are located within the Paradise Point and Camp Johnson areas aboard Marine Corps Base, Camp Lejeune, North Carolina.

Confirmatory soil analyses showed that residential limits were exceeded at the various locations described. We propose the following actions at each site:

PP-3326, PP-3330, PP-3332, and PP-3350: Re-excavate soils at locations exceeding residential MSCCs with the exception of the locations adjacent to the house foundations.

M230: Since soil contamination is at depth (11'), we are evaluating several technologies applicable to this particular case. We would like to further discuss this site with you at the upcoming partnering meeting to be held on February 24, 2005 at Camp Lejeune.
