All VSC Employees,

Good morning. I am providing some additional clarification to the below email. If you have claims for CLCW issues that can be granted, you may continue to process those. If a rating would deny any CLCW condition, those CLCW conditions must be deferred using the following language:

“The claim for XXX is deferred pending receipt of additional guidance.”

However, if nothing can be granted on the claim, do not complete a deferred simply for the purpose of documenting the claim is pending further guidance. It still needs to be added to the SharePoint CLCW Hold Tracker by the RVSR at this point, though.

Claims for **non**-CLCW issues can be granted or denied as needed. If those claims also involve CLCW issues, those must be deferred as indicated above.

Any claims on which we cannot take final action (deferred and/or partial grants), **must** be entered on the SharePoint CLCW Hold Tracker by the RVSR at the time the determination is made that the CLCW issue cannot be granted. The "Date of Determination" field should be the date you determined the CLCW conditions could not be granted. In most cases, this will be the date of the partial or deferred rating.

For those of you who are promulgating, if you have a claim that has already been rated that denies a CLCW condition, do **not** promulgate it. You **must** update the SharePoint CLCW Hold Tracker and reassign the claim to (b) (6).
