Dear Mr. Lucins:

We have reviewed the comments provided by your letter of December 20, 1988 regarding the Site Investigation Information Request for Marine Corps Air Station, New River. As discussed during a telephone conversation on February 4, 1989 between Mr. Victor Weeks of the Federal Facilities staff and Ms. Sheila Ashton of our staff, the following information is provided in response to your request. The numbers below correspond to the same numbers in your letter.

1. Narrative summaries are provided as enclosure (A). Because MCAS New River has generator status only, RCRA information pertaining to MCAS New River may be found in the Hazardous Waste Notifications forwarded to you by this Command on August 18, 1980. Please notify Ms. Ashton at the telephone number listed above if you need a copy of the notification.

2. The Initial Assessment Study for Marine Corps Base, Camp Lejeune contains all available documented waste quantity information for each potential CERCLA site at MCAS New River. A copy of this study was sent to your office for your records and should be a part of the jacket file for Camp Lejeune. For an additional copy of the IAS please contact Ms. Ashton.

3. Recent USGS topographic maps indicating three and four mile radii around each potential CERCLA site boundary will be provided directly to you by MCB Camp Lejeune no later than March 15, 1989.

4. Nearby public water supply system plans indicating distribution lines will be requested from the Onslow County Water System Manager by MCB Camp Lejeune no later than February 15, 1989. The information from the County Water System Manager will be forwarded directly to you by MCB Camp Lejeune by March 15, 1989.

5. A map indicating location of existing drinking supply wells on MCAS New River with available well logs and user documentation will be provided directly to you by MCB Camp Lejeune no later than March 15, 1989.

6. Two rounds of sampling and analysis have been completed for MCAS New River sites. A Remedial Investigation Interim Report will be prepared for not only the New River sites but for the other Camp Lejeune Installation Restoration Program sites as well. The data from the two rounds of sampling and the evaluation of the data will be forwarded to your Technical Review Committee representative when the report becomes available. We expect the release of the report by June 1989.
