1. AS DISCUSSED IN REFERENCES A, B, AND C THERE ARE SEVERAL ADDITIONS, COMMENTS, CLARIFICATIONS, AND CORRECTIONS NEEDED FOR THE SUBJECT AGREEMENT. ALTHOUGH EPA REGION IV HAS BEEN RECEPTIVE TO THE IDEA OF MAKING THESE CHANGES PRIOR TO EXECUTION OF THE SUBJECT AGREEMENT, WE ARE DISCONTINUING DISCUSSIONS UNTIL AFTER THE AGREEMENT IS SIGNED AS REQUESTED IN REFERENCE D. NONE OF THE AFOREMENTIONED CHANGES ARE CRITICAL TO THE EFFECTIVE MANAGEMENT OF THE IR PROGRAM AT MARCORB CAMP LEJEUNE. THE CHANGES DO, HOWEVER, PROVIDE IMPORTANT IMPROVEMENTS.
2. THESE CHANGES AND ALL FUTURE CHANGES WILL NEED TO BE HANDLED USING THE FORMAL AMENDMENT PROCEDURE ESTABLISHED IN THE FFA. THIS WILL ENTAIL NEGOTIATION, UNANIMOUS AGREEMENT, LETTER OF INTENT TO EXECUTE THE AMENDMENT, PUBLIC COMMENT, FINAL NEGOTIATION AND ISSUANCE OF THE AMENDMENT. WE EXPECT THIS PROCESS TO TAKE AT LEAST 90 DAYS FOR EACH AMENDMENT.
