Dear Ms. Glenn:

The referenced Work Plan was forwarded to your office on 11 April 1992. The referenced documents were changed significantly from the Draft versions due to the numerous and substantial comments concerning the Draft versions from your office. In the interest of making the significant changes required and submitting the referenced documents within the time frames specified in the Federal Facilities Agreement, the Navy/Marine Corps could provide only an abbreviated review of the Draft Final Project Plans before they were submitted.

During a recent and more thorough review of the referenced documents, we noticed some errors in the Project Plans, specifically the Work Plan and the Sampling and Analysis Plan, which we are in the process of correcting. Currently, the Draft Final Work Plan specifies that aquatic samples (surface water, sediment, fish, and shellfish) at Sites 48 and 69 will be analyzed for full TCL Organics/TAL Inorganics. However, the Navy/Marine Corps believe analysis of aquatic samples for full TCL Organics/TAL Inorganics without regard for the contaminants of concern at the respective sites is technically inappropriate and an unnecessary expenditure of Defense Environmental Restoration Account funds. As such, these portions of the Project Plans will be amended to specify that aquatic samples at these sites will be analyzed only for contaminants found at the respective sites.
