The undersigned, hereinafter called the "OWNER", hereby grants to the UNITED STATES OF AMERICA, hereinafter called the "GOVERNMENT", a permit or right-of-entry upon the following terms and conditions:

- 1. The OWNER hereby grants to the GOVERNMENT an irrevocable right to enter upon the lands hereinafter described at any time within a period of two (2) years from the date of this instrument, in order to survey, construct monitoring wells, take water samples and readings, and carry out such other exploratory work as may be necessary to complete the investigation being made by the GOVERNMENT.
- 2. The permit or right-of-entry includes the right of ingress and egress on other lands of the OWNER not described below, provided such ingress and egress is necessary and not otherwise conveniently available to the GOVERNMENT.
- 3. All tools, equipment, improvements, and other property taken upon or placed upon the land by the GOVERNMENT shall remain the property of the GOVERNMENT and may be removed by the GOVERNMENT at any time within a reasonable period after the expiration of this permit or right-of-entry.
- 4. The GOVERNMENT shall have the right to patrol and police the land hereinafter described during the period of this permit or right-of-entry.
- 5. The GOVERNMENT agrees to be responsible for damages arising from the activity of the GOVERNMENT, its officers, employees, or representatives on said land, in the exercise of rights under this permit or right-of-entry, either by repairing such damage or at the option of the GOVERNMENT by making an appropriate settlement with the OWNER in lieu thereof.
- 6. The land affected by this permit or right-of-entry is located in the State of North Carolina, County of Onslow, and is described as follows:

Being as shown on Baker Environmental, Inc., Drawing Figure No. 1, Site 35, Camp Geiger Fuel Farm Supplemental Groundwater Investigation, Marine Corps Base, Camp Lejeune, North Carolina, dated April 1996, attached hereto and made a part hereof as EXHIBIT A, and being as shown as Lot No. 7 on attached T. B. Henderson Farm survey map recorded in the Office of the Register of Deeds of Onslow County, North Carolina, in Map Book 1, Page 34, attached hereto and made a part hereof as EXHIBIT B. Said Lot No. 7 being more particularly described in Deed Book 176 Page 337 in the Office of the Register of Deeds, Onslow County, North Carolina.



