Baker Environmental, Inc. (Baker) is pleased to submit three copies of the replacement pages for the Final Site Evaluation Project Plans for Operable Unit No. 15 (Site 88) Marine Corps Base (MCB), Camp Lejeune. Additionally, three complete copies of the documents are being provided for the Administrative Record. These plans are being submitted in accordance with the schedule modification letter dated January 13, 1997 and signed by LANTDIV on January 21, 1997.

The plans provide information obtained during the Phase I investigation and the scope for the Phase II investigation agreed to by the Partnering Team in January 1997. Due to the number of revisions required to incorporate the Phase I investigation findings and scope of the Phase II investigation, complete copies of the Work Plan, Field Sampling and Analysis Plan, and Quality Assurance Project Plan have been provided. Instructions for insertion of the replacement pages are provided in Attachment A.

Two copies of the replacement pages have been forwarded to Mr. Neal Paul at the Environmental Management Department of MCB Camp Lejeune. Additional copies have been distributed to representatives of the United States Environmental Protection Agency (USEPA), North Carolina Department of Health and Natural Resources (NC DEHNR), the Naval Environmental Health Center (NEHC), the Agency for Toxic Substance and Disease Registry (ATSDR) and OHM Corporation as presented in the attached transmittal letters.

Formal comments are not expected on these final plans. The scope of work presented in these plans will be conducted during the Phase II investigation at this site. If additional investigation efforts are required an addendum to the Project Plans will be prepared to address the requirements of the additional investigation.
