1. During the reference, Mr. Alexander requested information on parameters for analysis, sample containers, and turnaround time for JTC to analyze some soil samples from Lot 203. Mr. Alexander's list of things to look for consisted of the following items:

Organochlorine Solvent	Oil & Grease
POL's	Pesticides
Metals (E. P. Tox)	

2. I called JTC that day. I spoke to Laura Perick at JTC and gave her Mr. Alexander's list over the phone. As for the parameters she recommended the following:

E. P. Toxicity for Metals and Pesticides  
Total Petroleum Hydrocarbon for POL and Oil and Grease  
VOCs for Organochlorine Solvent  
PCBs

3. On the question of sample containers Lori Petick stated that our present jars we have been using were adequate. *301/926/6802*

4. On the question of turnaround time she said she would have to get back with me after she talked to the laboratory directors because they were in the process of relocating. Ms. Petick called back on 9 Feb 1989 to say it would take a two week turnaround to analyze any of the soil samples.

5. I also inquired as to the best way to get a representative sample of layers of soil. Lori Petick stated that what they have done is have samples at different depths sent to them. The laboratory composite them and run the analysis. If anything significant is found then the lab can go back to the depth samples and analyze them individually to help determine at what depth the contamination is located.
